University of Portsmouth - New Training Partner

The University of Portsmouth has become an official INTERPOL Training Partner, following the signature of a Training Agreement on 2 June 2025. Training Partners complement the INTERPOL Global Academy Network (IGAN), contributing to its initiatives and bringing expertise in law enforcement-related studies.

To mark this milestone, on 5 and 6 June, the INTERPOL Global Academy hosted a group of international students from the University's School of Criminology and Criminal Justice for a two-day study visit to the INTERPOL General Secretariat in Lyon, France.





EAPCCO adopts recommendations on INTERPOL Global Academy

The Eastern African Police Chiefs Cooperation Organization (EAPCCO) adopted several recommendations aimed at strengthening regional use of and collaboration with the INTERPOL Global Academy at its Organs Meeting, held from 22-24 April in Kigali, Rwanda.

Amongst others, the recommendations urged EAPCCO member countries to benefit from online courses offered by INTERPOL Global Academy Network members, as well as trainings offered by the INTERPOL Virtual Academy. It was also recommended that EAPCCO member countries consider joining the INTERPOL Global Academy Network.

Expanding Knowledge: Serbian University offers international course on TOR and Crypto

The University of Criminal Investigation and Police Studies of Serbia welcomed 13 international participants for its TOR, Darknet, and Crypto Essentials training held on campus from 7–11 April 2025. The University kindly provided accommodation and meals, encouraging networking alongside in-depth learning about the TOR browser, darknet access, and crypto assets.

The course was also streamed live, enabling 87 additional online participants worldwide to benefit.

High demand continues for City of London Police online courses

The Economic and Cyber Crime Academy (ECCA) of the City of London Police continued to offer two online courses on a monthly basis to global law enforcement in April, May and June.

As of end June, 510 seats had been granted on ECCA's Demystifying Cybercrime course and 627 on its course on Blockchain and Cryptocurrencies

First online course on Drugs offered by National Police of Colombia in April 2025

The National Police of Colombia offered 30 seats to participants from 12 countries in the Americas and Europe to its online Diploma on Interdiction Procedures for Illicit Drug Control.

The course was held in Spanish throughout April. 21 participants successfully completed the course.



Empowering Digital Forensic First Responders Worldwide: 43 officials complete NFSU course

43 officials from 24 countries completed the online course "First Responders' Roles and Responsibilities for Search and Seizure of Digital Evidence" offered by the National Forensic Sciences University of India from 14-16 May 2025. This course, the first offered by an INTERPOL Training Partner, is one of five courses to be delivered by NFSU in 2025 for INTERPOL member countries.

17 participants from INTERPOL member countries took part in specialist international training hosted by the University of Criminal Investigation and Police Studies of Serbia. The course focused on detecting and dismantling illegal drug laboratories, including those producing precursors and new synthetic substances, as well as emerging global trends in drug production and smuggling.

Held from 12–22 May 2025 at Mount Goč, the in-person training attracted attendees from Africa, Asia, Europe, and the Middle East. The University generously provided accommodation and meals to all participants.

The Minister of Interior and the Rector of the University presented successful participants with certificates at a formal ceremony at the Ministry of Interior.





Spanish National Police Academy runs 5th C1b3rWall Congress

The Clb3rWall Congress was held at the Spanish National Police Academy from 3-5 June.

This 5th edition of C1b3rWall centered on the theme "Trusted Digital Identity", and the urgent need to protect individual and institutional identities amid rising digital threats.

For the second year running, the Police Academy kindly offered participants applying via the INTERPOL Global Academy seats at the Congress, as well as meals and accommodation. Six participants from the Americas Europe and MENA took part.







CBI Academy of India provides training on CyberCrime and Digital Forensics

From 23-27 June, the CBI Academy of India ran an online course on Cybercrime and Digital Forensics for INTERPOL member countries. It is the second time that it has offered the course as part of the Network Catalogue of Continuing Education.

A total of 76 participants from 33 countries completed the course.

University Institute of Federal Police of Argentina launches Spanish-language Course on International Criminal Police Cooperation

On 17 June, IUPFA launched its online course on International Criminal Police Cooperation. The third consecutive year the course has been offered in the Network Catalogue of Continuing Education, 24 participants from 12 countries that applied via the Global Academy are taking part.

The course runs until 25 August.





NFSU trains 20 officials on Advanced Methods of Psychological Investigation

20 officials from 9 countries travelled to the Gujarat campus of the National Forensic Sciences University of India (NFSU) to attend the course on Advanced Methods of Psychological Investigation from 9-21 June.

Through hands-on training and exposure to cutting-edge tools, participants learnt how to apply psychological techniques, collect and analyse behavioral evidence, and prepare for effective suspect screening and legal proceedings.

Expert insights from Serbia: Al in OSINT




As part of INTERPOL's online programme on the Fundamentals of Open Source Investigations (FOSI), two experts from Serbia's University of Criminal Investigation and Police Studies, Nikola Čučilović and Nenad Bogunović, delivered a live webinar on the role of Artificial Intelligence (AI) in OSINT investigations. The university, an IGAN member, brought its expertise to the forefront in this engaging session.

The webinar, attended by 111 participants, provided an overview of the benefits and drawbacks of leveraging Al in OSINT investigations, with a special focus on the emerging challenge of deepfakes. Four participants nominated by IGAN members also completed the FOSI programme.
